Total number of Candidates included in the Eligibility List : 20

Note :- (1) Inclusion of register numbers in this list is purely provisional. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared on the basis of the Main Examination.

Note :- (2) The register number of candidates who have secured top mark in the OMR Test (Common Preliminary) are included in the list.

Note :- (3) The candidates who have secured 40(Forty) marks and above in the Common Preliminary OMR test are included in the eligibility list. The candidates included in the list shall have to prove their claim by producing Non Creamy Layer Certificate at the time of One Time Registration Verification, if they are included in the list to be published after the final examinations. If they fail to prove their claim, their application will be summarily rejected

Note :- (4) The marks secured in the Common Preliminary Examination by the candidate will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note :- (5) If any of the documents produced by any candidate is found defective, the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (6) According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs.85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time

to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Eligibility List is uploaded in the website of the Commission.(on or before 01/08/2025)

Note :- (7) Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Eligibility List is uploaded in the website of the Commission.(on or before 01/08/2025) Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

Note :- (8) No answer script are invalidated as per Notification No. ER4B2/3/2025-KPSC dated 16/07/2025.
