Note:- (2) The Probability list has been prepared by including eligible and qualified candidates who have secured top marks in the OMR Test, based on the details furnished by the candidates in the application for the post. Subsequent claims made will not be entertained at any stage.

Note :- (3) 52 (Fifty Two) candidates who have secured top most marks in the OMR examination are included in the main list of this Probability List. The marks secured by the last candidate in the Main List is **69 (Sixty Nine)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary lists prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of One Time Verification will be intimated through Profile message and SMS

Note:- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Probability List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules 2002 and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents mentioned, at the time of One Time verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on 28.02.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER6-1/1/2025-KPSC Dated 10-07-2025
