

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) 10 (Ten ) candidates who have secured topmost marks in the Descriptive Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **33.75 ( thirty three (point) seven five )** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) Candidates included in the Short List should present in person and produce the original documents for One Time Verification. Date, time and Venue of OTR Verification will be published in due course.

Note :- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (7) According to the existing procedure rechecking and revaluation of answer scripts are not allowed. Detailed instructions will be published in the Ranked List to be published for the post. Scanned image and Tabulation sheet of answer scripts of the Descriptive Test held on 02-05-2024 will be issued to the candidate who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer script is invalidated as per Notification No: ERI-2/9/2024-KPSC dated 16/07/2025.
