Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Community included in the Probability List are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala(Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificate Rules,2002 and candidates belonging to Other Backward Classes included in the Probability List are required to produce Non-Creamy Layer Certificate as per GO(P) No:81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No:3942/2018/RD dated 24.09.2018 and candidates belonging to EWS category are required to produce EWS certificate issued by the Revenue Authority vide GO(MS) No:2/2020/P&ARD dated 12.02.2020 at the time of One Time Verification along with other original documents.
