

Note :- (7) Copy of answer scripts of the Common OMR Test held on 24.4.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.
