If any of the documents produced by any candidate is found defective, the Commission reserves the right for rejection of his candidature at any stage of selection as per rule.

Note :- (4) 54 (Five Four) candidates who have secured top marks in the OMR Examination are included in the Main List of this Short List. The mark secured by the last candidate in the Main list is **37.67 (thirty seven (point) six seven)** Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes and Economically Weaker Section (and other reserved categories if any) necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be intimated in due course.

Note:- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/STDD dated, 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated, 24.09.2018 and SC/ST Candidates are required to produce Community Certificate (Form III / Digitally Signed) issued by the Revenue Authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate vide GO(Ms) No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **25-04-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer Script is invalidated refer to Notification No : ER16-2/62025-KPSC Dated 21-06-2025
