Note :- (3) 20 (Twenty) candidates who have secured top most marks in the OMR examination are included in the Main List of the Short List. The marks secured by the last candidate in the Main list is **43.33 ( forty three (point) three three )** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes ,Other Backward Classes , Economically Weaker Section and Differently abled, necessary Supplementary Lists are prepared by including sufficient numbers of candidates from lower marks ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short list should present and produce in person the original documents for OneTime Verification. Date,time and Venue of OTR Verification and Interview will be intimated to the Candidates through Profile Message and SMS in due course.

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules,2002 and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List notification to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **18-12-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (9) No Answer Scripts of Candidates are invalidated as per Notification No : ER15-3/3/2025-KPSC Dated 17.07.2025
