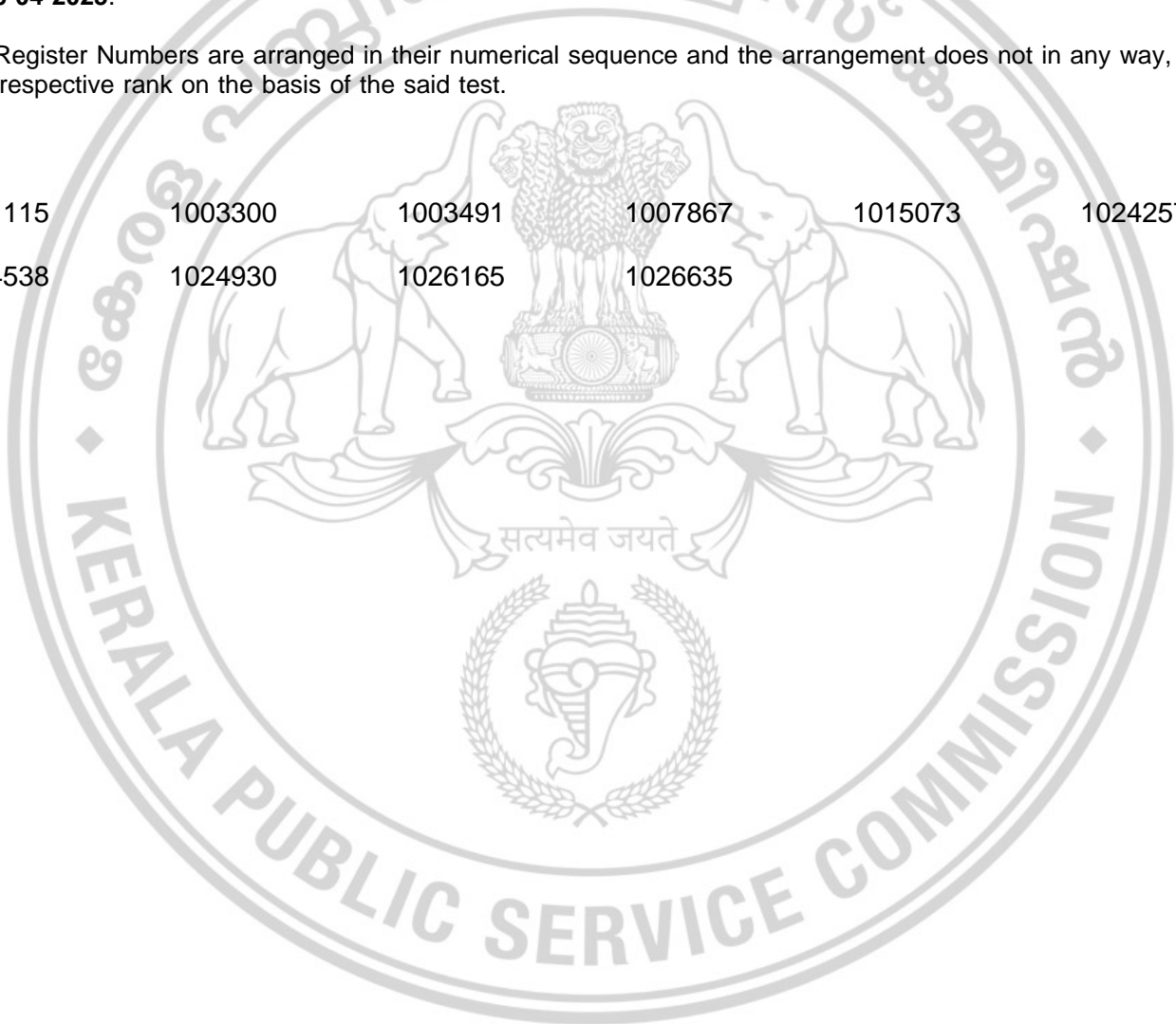

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be published in due course.

Note:- (5)The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability list without further notice.

Note:- (6) Candidates included in the Probability List are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar along with other documents at the time of OTR Verification.

Note:- (7) According to the existing procedure, revaluation of answer script is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post

Note :- (8) Copy of answer scripts of the OMR Test held on 26.04.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per invalidation notification No : **ER2-1/5/2025-KPSC Dated 27.06.2025.**
