Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) 63 (Sixty Three) candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **50 (Fifty)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Economically Weaker Section, Other Backward Classes and Differently Abled categories, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) The short list is prepared based on the details furnished by the candidates in the applications and subsequent claims made will not be entertained at any stage.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification & Interview. Date, time and Venue of One Time Verification & Interview will be published in due course.

Note :- (5) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 28.06.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 along with other documents mentioned, at the time of verification of original documents. Candidates belonging to SC/ST Category are required to produce Community Certificate and Candidates belonging to EWS Category are required to produce EWS Certificate issued by the Revenue authority along with the other documents at the time of verification of Original documents. Candidates belonging to Differently Abled categories are required to produce Disability Certificate and Job Oriented physical and Functionality Certificate issued by the Medical Authority along with the other documents at the time of verification of Original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the OMR Test held on **10.06.2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) No answer scripts are invalidated as per Notification No : ER 16-1/5/2025 KPSC dtd.19.07.2025
