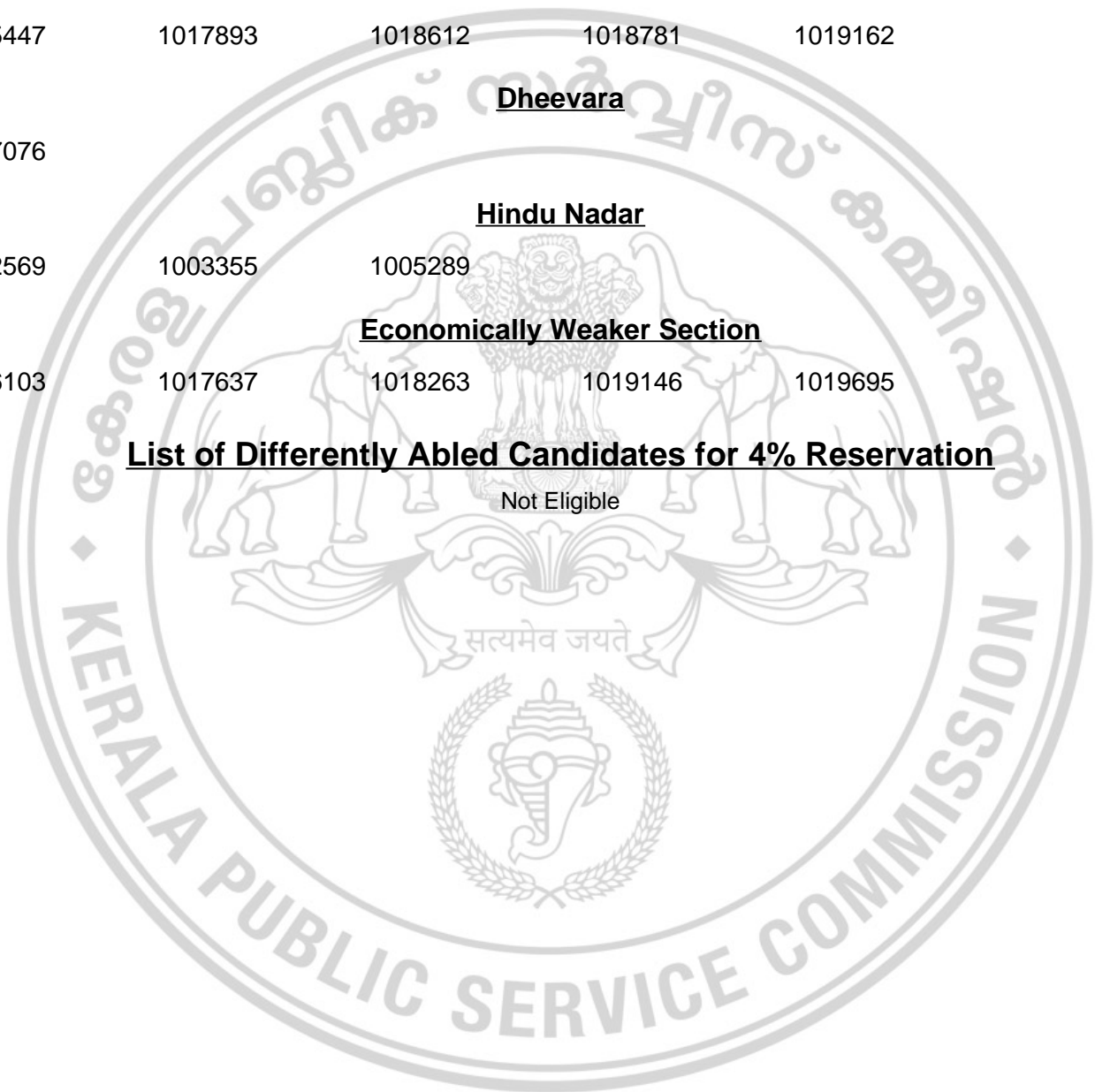

Note:- (2) The Probability list has been prepared by including eligible and qualified candidates who have secured top marks in the OMR Test held on 26.04.2025, based on the details furnished by the candidates in their application for the post. Subsequent claims made will not be entertained at any stage.

Note :- (3) 31 (Thirty One) candidates who have secured top most marks in the OMR Test are included in the main list of this Probability List. The marks secured by the last candidate in the Main List is 73 (Seventy Three) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of One Time Verification will be intimated through Profile message and SMS.

Note:- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate in the format prescribed vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 26.04.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are Invalidated for this post as per Invalidation Notification No : ER2-1/5/2025-KPSC Dated 27/06/2025.
