NOTE (1) :- The candidates included in the above list (Part II By Transfer) will be advised for appointment against vacancies reported to the Commission in accordance with the rules and orders regarding rotation as amended from time to time. 10% of the vacancies reported to the Commission will be filled up by candidates included under Part II (By Transfer). Those candidates who are left unadvised in this list at the time of cancellation will be included at the top of the new list drawn up subsequently by the Commission.

NOTE (2) :- According to the existing procedure, revaluation of Answer Script is not allowed. But the OMR Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie., via email/Tapal/Direct) will not be considered. A period of 15 days (Fifteen) time to apply for rechecking of OMR Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission, ie: on or before **15.08.2025**.

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie: on or before **15.08.2025**. Applications submitted in any other manner (ie., via email/Tapal/Direct) will not be considered. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall make the same in the format prescribed by the Commission to the District Officer, Kerala Public Service Commission District Office, Tiger Hills, Municipal Office Road, Pulikkunnu, Kasaragod 671121. The format is available in the official website www.keralapsc.gov.in of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of

requisition, based on which he/she is to be advised.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked List included in the Common Test.
