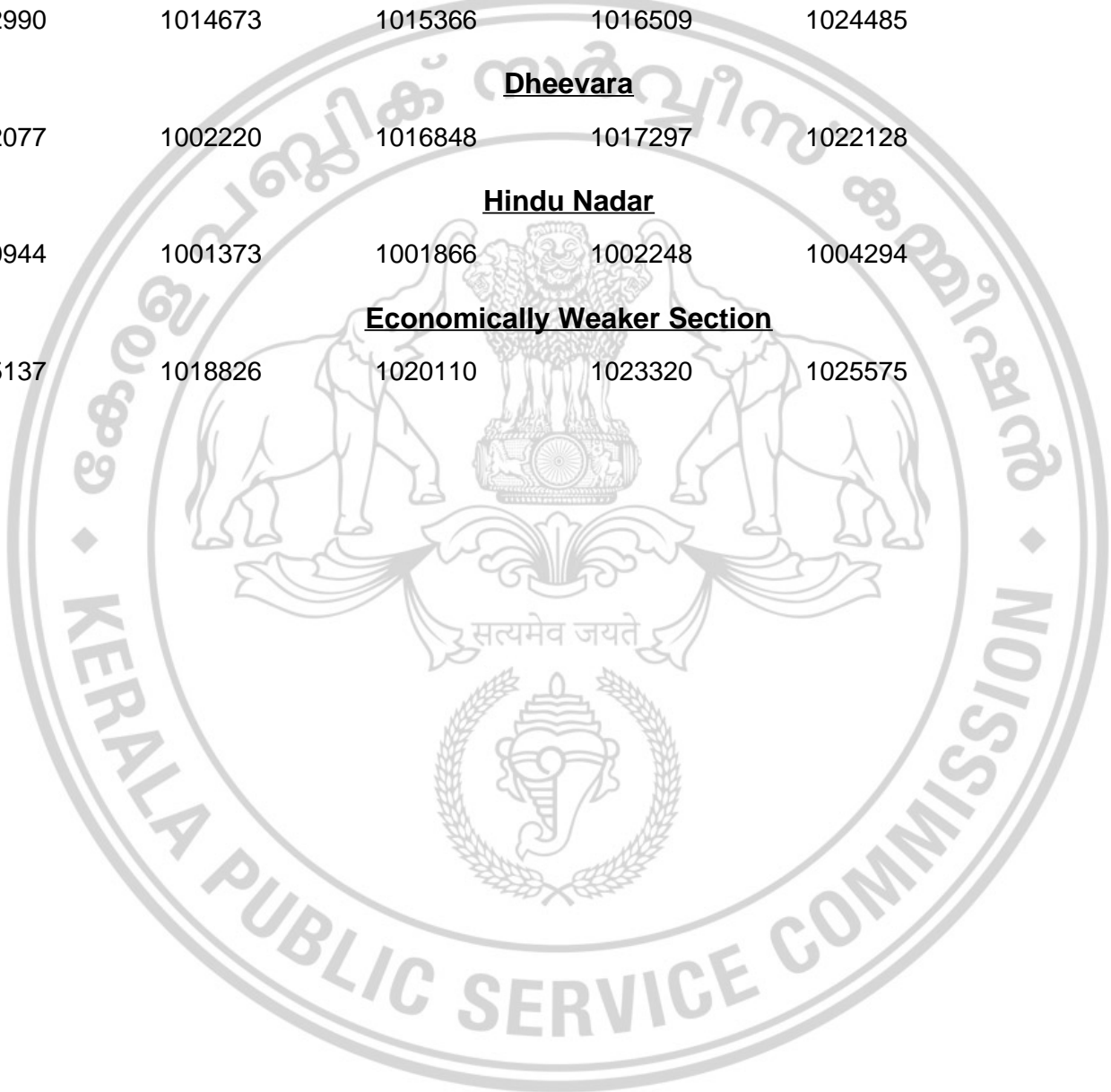

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test, based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) 30 (Thirty ) candidates who have secured top marks in the OMR examination are included in the Main List of this Probability List. The marks secured by the last candidate in the main list is 80.67(Eighty (point) six seven ) marks. For the purpose of satisfying the Rules of Reservation of appointment to Scheduled Castes, Scheduled Tribes, other Backward Classes and Economically Weaker Section necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be intimated through profile Message and SMS in due course.

Note:- (5) Candidates belong to Other Backward Classes included in the Probability List, eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt)no.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate(Form III/Digitally signed) issued by the Revenue Authority not below the rank Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS).No.02/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on 26.04.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script are invalidated as per Notification No.ER2-1/5/2025-KPSC dated 27/06/2025.
