Note :- (3) 22 (Twenty Two) candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **33.33 ( Thirty Three (point) Three Three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Economically Weaker Section, Other Backward Classes and Differently Abled categories, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person and produce the original documents for One Time Verification and interview. **Date, time and venue of One Time Verification & Interview will be intimated through profile messages and SMS in due course.**

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dated. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) According to the existing procedure, revaluation are not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the Common OMR Test held on 25-04-2025 will be issued to those candidates who apply for the same by remitting the prescribed fee only after the publication of entire Ranked Lists which will be finalized on the basis of Common test. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) No answer scripts are invalidated as per Notification No. ER 16-2/62025-KPSC dated 21.06.2025.
