Note :- (6) Candidates included in the Short List are required to produce **Community Certificate issued by the Revenue authority along with other relevant documents at the time of OTR Verification.**

Note :- (7) Copy of answer scripts of the OMR Test held on 17.05.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
