Note :- (2) The short list has been prepared by including the number of candidates who have secured top marks in the Common OMR Test held on 17.05.2025

Note :- (3) **199 (One Hundred and Ninety Nine)** candidates who have secured top most marks in the OMR Examination are included in the Main List of Short List. The marks secured by the Last candidate in the Main List is **57.33 ( fifty seven (point) three three )**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically weaker sections, necessary supplementary List is prepared by including sufficient numbers of candidates from lower mark range in the order of merit of candidates belonging to such classes.

Note :- (4) An Endurance Test will be conducted for the candidates included in the Short List. Date, Time and Venue of Endurance Test will be intimated in due course by SMS/Profile Message. Candidate should download their Admission Ticket for the Endurance Test from the KPSC Website and should appear in person with their original documents including Medical Certificate for verification.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009. Candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally signed issued by the Revenue Authority not below the Rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS certificate in the format prescribed vide G.O (MS) No.2/2020 P&ARD Dated 12.02.2020 issued by the village officer as proof of their claim along with other relevant documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-05-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of **No** Candidates are invalidated as per invalidation Notification No : ER7-2/9/2025-KPSC dated 23.07.2025
