Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated.
