NOTE (5):- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed Fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** via e-payment mode available in the portal. A period of **15 (Fifteen)** days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (**on or before 07.10.2025**). Application submitted in any other manner (ie, via E-mail/Tappal/ Direct) will not be considered. A copy of answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Please note that in case of Ranked lists of those posts for which common examinations were conducted, the copy of OMR sheets will be provaided only after the publication of the Ranked lists of those posts for which the candidates has participated.

NOTE (6):- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List.
