NOTE (1): Inclusion of candidates with the qualifications GNM/B.Sc Nursing in the list is provisional and any appointment made shall be subject to the result of OP(KAT) No. 253/2021 & SLP(C) No. 13242/2021.

NOTE (2): According to the existing procedure, revaluation of Answer Scripts is not allowed. However, Answer Scripts will be rechecked if candidates apply through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of **Rs. 85/- (Rupees Eighty Five only)**. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded on the website of the Commission (on or before **26.09.2025**)

NOTE (3): Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit an online application through their One Time Registration profile from the official website of the Commission **www.keralapsc.gov.in** by remitting the prescribed fee of **Rs. 335/-** (**Rupees Three Hundred and Thirty Five only**) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded on the website of the Commission (on or before **26.09.2025)** Applications submitted in any other manner will not be considered. A copy of the Answer Sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer Sheets will be provided only after the publication of all the Ranked Lists of those posts in which the candidate has participated.

NOTE (4): The entries put in Column (5) are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. Candidates whose Communities have not been correctly noted in the Ranked List, as proved by them in their application, should intimate the fact to The District Officer, Kerala Public Service Commission, District Office, Thiruvanathapuram – 695004 within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled. In the absence of timely information regarding discrepancies, if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (5): Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to The District Officer, Kerala Public Service Commission, District Office, Thiruvanathapuram – 695004. The format is available on the official website of the Commission. The request for relinquishment in respect of those who do not submit the application in the prescribed format will not be honoured under any circumstances. The request in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal, along with a notarized affidavit and self-attested copy of an ID proof, received within 15 days from the date of publication of the Ranked List on the official website of the Commission. Such requests will be honoured against requisitions of vacancies pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which the candidate is to be advised.

NOTE (6): Since a **common OMR Test with common candidates** was conducted for this post, the marks awarded to the candidates included in this Ranked List and the marks of the OMR Test relating to all candidates who appeared for the test will be published only after the publication of the **entire Ranked Lists (including NCA Notifications)** which will be finalised on the basis of the common test.

NOTE (7): The result of rechecking of OMR Answer Scripts will be intimated in due course. However, photocopies of the OMR Answer Scripts of common test will be issued only after the publication of all the Ranked Lists for all those posts for which the candidates has participated.

NOTE (8): The A part and B part of OMR scripts of the common test will be destroyed after completing 6 months period from the date of finalisation of all Ranked lists.
