NOTE (2) :- Since a Common Online Test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of Online Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications, if any) which will be finalized on the basis of the Common Test.

The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission (ie. on or before 10.10.2025) will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. In the case of the requisition of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
