NOTE (3):- According to the existing procedure, revaluation and rechecking of answer sheets is not allowed.

NOTE (4):-Candidates who wish to obtain the image and tabulation sheet of their answer sheet relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission **www.keralapsc.gov.in** by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and thirty five only) via e-payment mode available in theportal. A period of 15 (Fifteen) days time (i.e on or before **11.08.2025**) to apply for photocopy of answersheets will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website,of the Commission. Application submitted in any other manner will not be considered. A copy of an answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued. Image and tabulation sheet will be issued to those candidates who have applied for this post only. For those who have applied for more than one category of posts included in the Common Descriptive Test, the image and tabulation sheet will be issued only after publishing the Ranked List for all the posts for which they have applied for.

NOTE (5):- The entries put in column **(5)** are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whoseCommunities have not been correctly noted in the Ranked List as proved by them in theirapplication should intimate the fact to the **The Deputy Secretary (Examinations) -III, Kerala PublicService Commission, Thiruvananthapuram - 695004** within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

The request for relinquishment along with aNotarizedAffidavit and a self attested copy of the ID Proof received within 15 days from the date of publication ofRanked List inthe official website of the Commission will be honoured against the requisitions of vacancies that arepending with theCommission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
