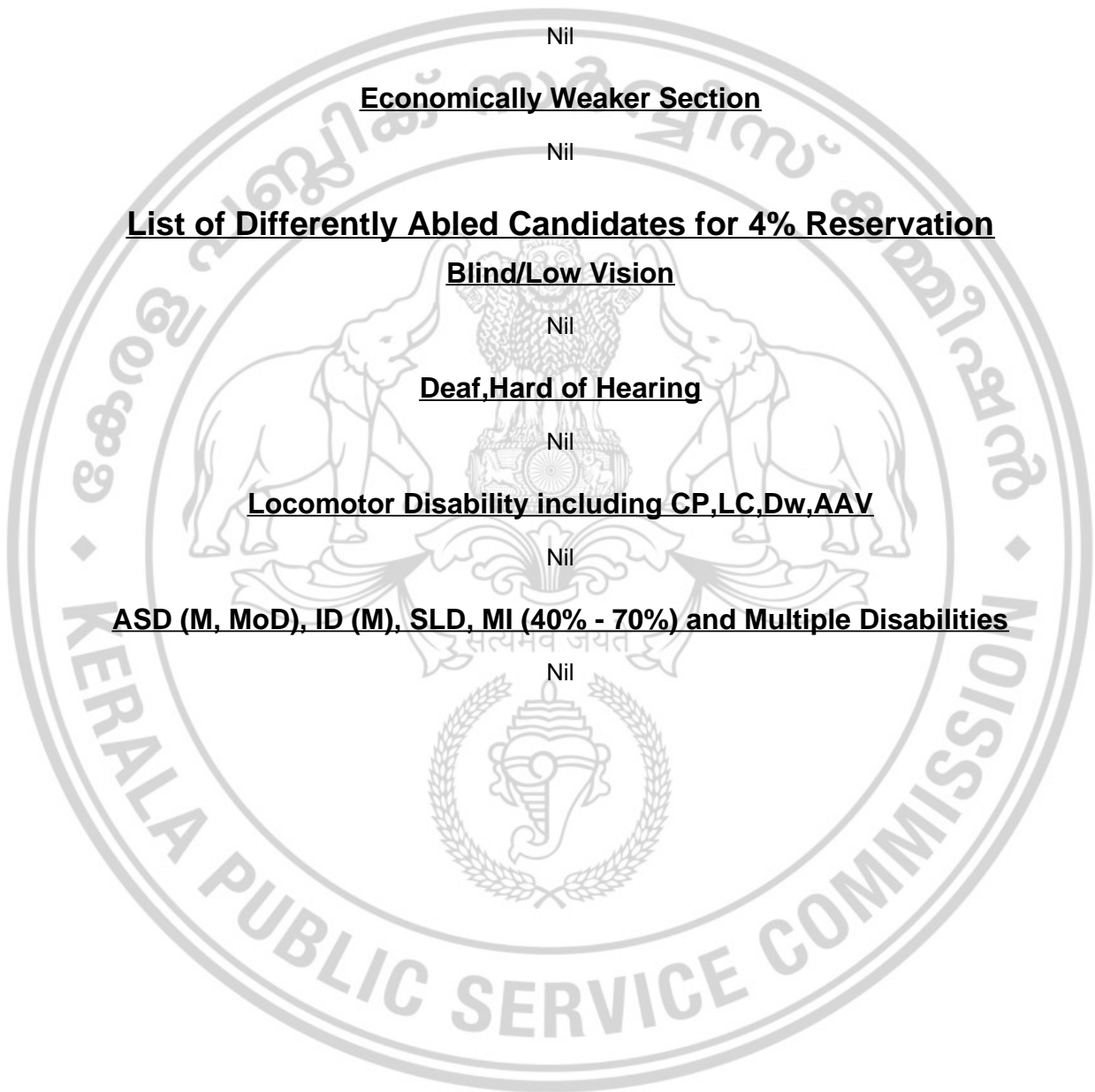

Detailed instructions will be furnished in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P)No.81/09/SCSTDD dtd 26.09.2009 at the time of OTR Verification.
