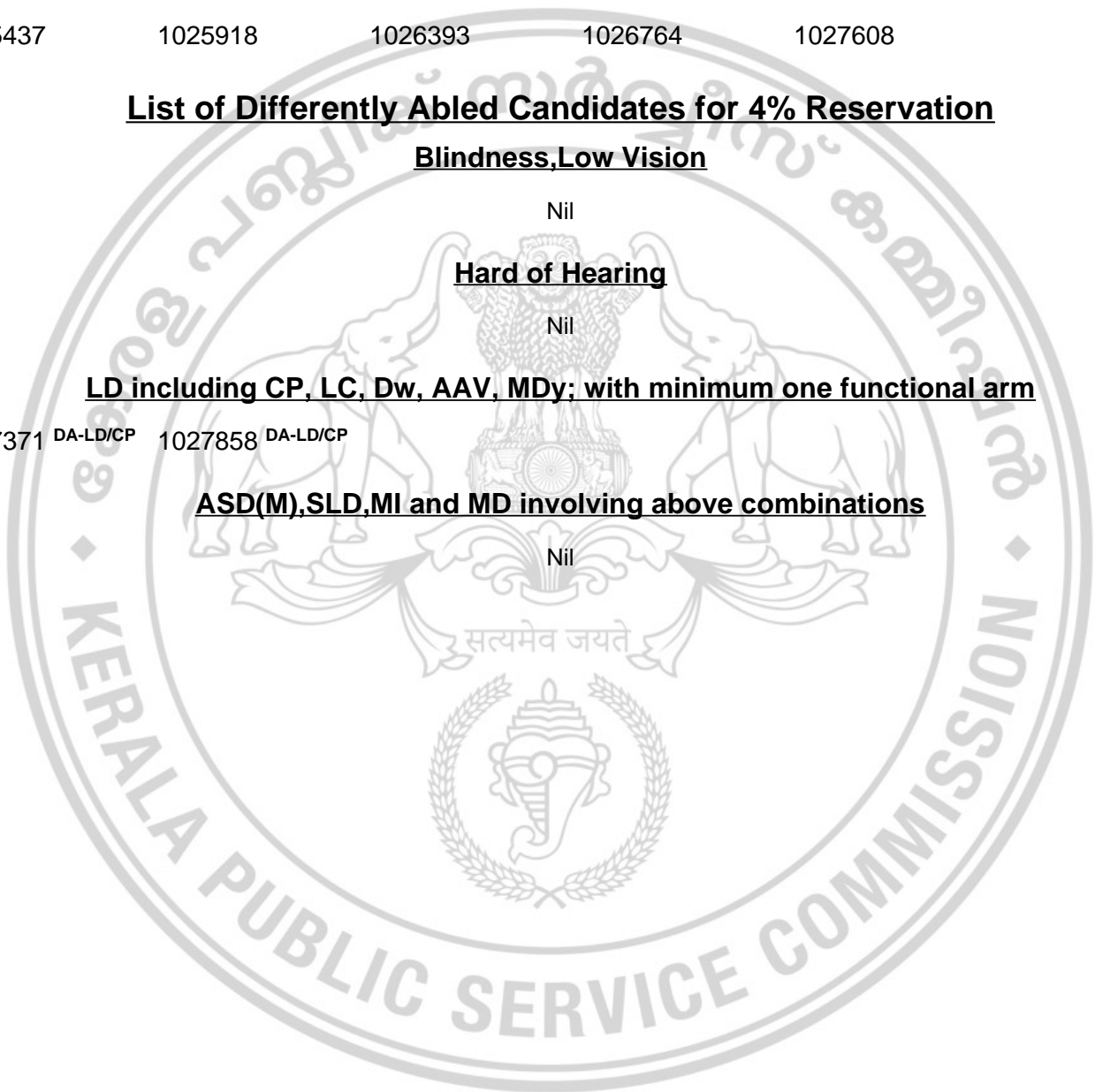

Note :- (3) 11 candidates who have secured top marks in the OMR Examination are included in the Main List of the Short List .The mark secured by the last candidate in the Main List is **57(fifty seven)**.For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled tribes ,Other Backward Classes and Economically weaker Section category necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview . **Date,time and Venue of OTR Verification and interview will be intimated through profile message /SMS.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 23/2020/P&ARD Dtd.12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **07-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER16-2/8/2025-KPSC dated 19/09/2025.
