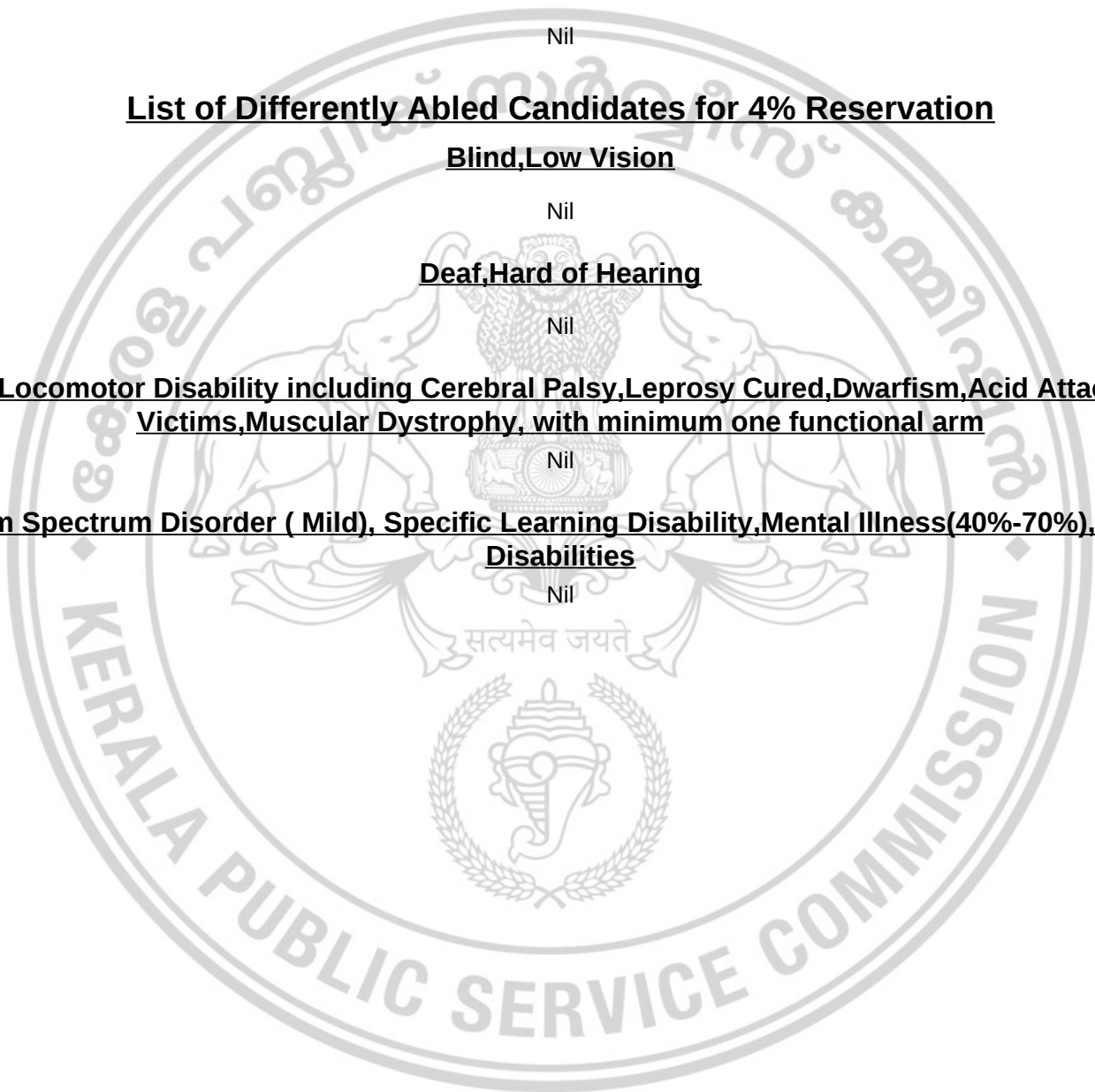

For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :-(4) Candidates included in the Short List should be present and produce in person the original documents for One Time Verification & Interview. Date,time and Venue of OTR Verification & Interview will be intimated through profile message and SMS in due course.

Note :-(5) The Register number of those candidates who do not produce the required documents within the prescribed time limit and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :-(6) Candidates belonging to Other Backward Classes included in the Short List are required to produce NonCreamy Layer Certificate issued by the Village Officer as per G.O.(P) NO. 81/2009/SC/STDD dated 26.09.2009 candidates belonging to SC/ST are required to produce Community Certificate in Form III/ Digitally signed by the Revenue Authority not below the rank of Tahsildar and candidates who belonging to EWS are required to produce EWS Certificate vide G.O.(MS) No.2/2020/P&ARD dated 12/02/2020. issued by the concerned Revenue authority at the time of OTR Verification along with other documents.

Note :-(7) For Online Examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List.Detailed instructions will be furnished in the Ranked List to be published for the post.
