The mark secured by the last candidate in the Main List is 57 ( Fifty Seven). For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled tribes, Other Backward Classes and other reserved categories if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note 4. Candidates included in the Short List should present in person and produce the original documents for One Time Verification and Interview. Date, time and Venue of OTR Verification and Interview will be published shortly.

Note 5. The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note 6. Candidates belonging to the Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 23/2020/P&ARD Dtd.12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note 7. For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
