Note :- (3)**Candidates must possess valid Driving Licence with endorsement for driving heavy goods vehicle or heavy passenger vehicle with badge throughout all stages of selection, ie,on the last date of receipt of application , date of OMR Test, date of Physical Efficiency Test and Practical Test.**

Note :- (4) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test. All eligible and qualified candidates who attended the OMR Test held for the post have been included in the list.

Note :- (5) **Date, Time and Venue of Physical Measurement , Physical Efficiency Test will be published shortly. At the next stage of selection process, a short list will be published for the Practical Test (Driving Test) by including the candidates who pass in Physical Measurement and Physical Efficiency Test.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **15-07-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER4 B1/4/2025-KPSC dated 11.09.2025.
