Note :- (3) 10 (TEN) candidates who have secured top marks in the Common OMR Examination held for the post on 07.08.2025 are included in the Main List of the Short List . The marks secured by the last candidate in the Main List is 53.67 (Fifty Three point six seven) marks . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes Other Backward Classes and Economically Weaker Section category ,necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be intimated through profile message and SMS in due course.

Note :- (5) The Register numbers of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates belonging to other Backward Classes included in the short list are required to produce Non Creamy Layer Certificate as per G.O.(P) NO. 81/2009/SC/STDD dated 26.09.2009 issued by Village Officer and candidates belonging to SC/ST are required to produce Community Certificate in Form III /Digitally signed issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No 23/2022/P&ARD dated 04/10/2022 issued by the Revenue authority along with other documents at the time of OTR Verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held for the post on 07.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List. No answer scripts of the candidates are invalidated as per Notification No: ER16-2/8/2025-KPSC Dated 19.09.2025 of the Secretary, Kerala Public Service Commission.
