Candidate should download their Admission Ticket for the Physical Measurement and Physical Efficiency Tests from the KPSC Website (www.keralapsc.gov.in) and should appear in person with their original documents including Admission Ticket, Medical Certificate and Valid Identity Proof for verification.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009. Candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally signed issued by the Revenue Authority not below the Rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS certificate in the format prescribed vide G.O (MS)No.2/2020 P&ARD Dated 12.02.2020 issued by the village officer as proof of their claim along with other relevant documents at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **17-05-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
