

Note :- (4) The Physical Measurements of the candidate will be taken prior to the Physical Efficiency Test and if the candidate does not possess the prescribed physical measurements, he will not be admitted for the Physical Efficiency test. If accidents or injuries happen to the candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (5) The Shortlisted candidate is required to produce Service Certificate in the format prescribed in the Gazette Notification along with the other relevant documents at the time of OTR verification of original documents.
