Note :- (2) The Short list is prepared by including eligible and qualified candidates who have secured top marks in the OMR Test, based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) **72 (Seventy Two)** candidates who have secured top most marks in the Common online test held for the post on **20.08.2025** are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is **58.67 (Fifty Eight (point) Six Seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Sections (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date, Time and Venue of One Time Verification and Interview** will be intimated through profile message & SMS in due course.

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 03/2024 Dtd. 25.04.2024 (annexure II/IV) as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) The register numbers of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the probability list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **20/08/2025** will be issued to those candidates who apply for the same remitting the prescribed fee, after the approval of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.
