The shortlisted candidates should download their Admission Ticket for the Physical Measurement and Physical Efficiency Test from their OTR profile, logging on to the official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of Kerala Public Service Commission and appear in person with their Admission ticket,original ID Proof and Medical certificate (in the form prescribed as per the Gazette notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Thasildar along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 26/07/2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscripts are invalidated as per Notification No :ER 16-2/7/2025-KPSC dated 06/10/2025.
