Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (3):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the District Officer, Kerala Public Service Commission, District Office, Palakkad - 678001. The format is available in the official website of the Commission.
