Note :- (2) The Short List is prepared based on the details furnished by the candidates in the application, and subsequent claims made will not be entertained at any stage.

Note:- (3) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (4) 15 (Fifteen) candidates who have secured the topmost marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **30.33 (Thirty(point) three three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories, if any), necessary Supplementary Lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.**

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of One Time Verification and Interview will be informed through Profile Message and SMS in due course.**

Note :- (6) The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit, and whose applications are found otherwise defective, will be deleted from the Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce Community Certificate issued under Rule 4 of the Kerala (SC/ST) Regulations of Issue of Community Certificate Rules, 2002 by the Revenue Authority not below the rank of Tahsildar. Candidates claiming reservation under the EWS category are required to produce EWS Certificate issued by the Village Officer as per G.O.(Ms) No.2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **28-07-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.**

Note:-(10) No Answer Script of Candidates are invalidated for this Post as per Notification No. ER6-1/3/2025-KPSC dated 15/09/2025.
