Note :- (3) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test held on 04.08.2025.

Note :- (4) **21(Twenty One)** Candidates who have secured top marks in the OMR examination are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is **46 (Forty Six)**. For the purpose of satisfying the rules of reservation of appointment to scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List should present and produce in person with the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be intimated through Profile message & SMS in due course.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate as per G.O.(MS) No.2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (8) The Register Number of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (9) Copy of answer scripts of the OMR Test held on 04-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated .
