Note :- (2) The short list is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **30(Thirty)** candidates who have secured top most marks in the common OMR examination are included in the Main List of this Short list. The Marks secured by the last candidate in the Main List is **53 (fifty three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and other reserved categories if any, necessary supplementary list is prepared by including available/sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short list should present and produce in person the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be published shortly .

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce Community Certificate either in form III or digitally signed Certificate issued by the Revenue Authority not below the rank of Tahsildar. Candidates claiming reservation under the EWS category are required to produce Income and Asset Certificate issued by the Village Officer as per G.O.(Ms) No.2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **04-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No. ER 7-2/12/2025 - KPSC dated 18/10/2025 .
