Note :- (2) The Short list has been prepared by including the number of candidates who have secured top marks in the OMR Test based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **124 (One Hundred And Twenty Four)** candidates who have secured top most marks in the OMR Examination are included in the Main List of the Short List. The marks secured by the last candidate in the Main List is **59 (Fifty Nine)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section and Differently Abled, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present and produce in person the original documents for One Time Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be published shortly.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to **Other Backward Classes** included in this list are required to produce **Non Creamy Layer Certificate** issued by Village Officer as per G.O.(P) No. 81/2009/SC/STDD dated 26.09.2009, candidates belonging to **SC/ST** are required to produce **Community Certificate** in Form III /Digitally signed issued by the Revenue authority not below the rank of Tahsildar and candidates belonging to **Economically Weaker Section** are required to produce **EWS Certificate** vide G.O. (M.S) No. 2/2020/P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 20.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER7-3/3/2025-KPSC Dated 31.10.2025.
