### **NOTIFICATION**

It is hereby notified that no eligible candidates are available for selection to the post of Confidential Assistant Gr.II (Part II – By Transfer) (Cat.No.522/2024) in Various Departments on Rs. 27,900-63,700/- in Kozhikode District in response to the notification published in the gazette dated 30/12/2024. Hence all further selection procedures relating to the above post remains cancelled.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their one time registration profile from the Commission's Official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 days (Fifteen days) time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission. The candidates can avail only one chance for rechecking after the Approval of Shortlist/Notification within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Candidates who have submitted the application for rechecking of the OMR answer scripts will be informed of their results through profile message only. Such message can be viewed by logging on to their 'One Time Registration' profile using their User ID and Password.

Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time

Registration profile from the official website of the Commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and ThirtyFive only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Shortlist/Notification is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of the answersheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
