

The following is the list of candidates for selection to the post of CLERK (TAMIL & MALAYALAM KNOWING)[Part II-Recruitment -By Transfer ]( Cat No:599/2023) on RS.26,500-60,700/- in VARIOUS DEPARTMENTS in THIRUVANANTHAPURAM DISTRICT. Candidates who have secured 40% (forty percent) and above marks with a separate minimum of 40% marks for the regional languages viz Tamil and Malayalam in the Descriptive Test held on 10.07.2025 are included in the Ranked List. This Ranked List is brought into force with effect from 28.11.2025.

As there is no previous selection for this post a fresh Ranked List has been prepared accordingly.

**NOTE (1)**:-The candidates included in this list will be advised against 10% of the vacancies reported to this office for the post. The rules regarding the reservation of appointment as contemplated in the General rules 14-17 of Part II of the KS& SSR 1958 are not applicable to this appointment. If sufficient number of candidates are not available to fill up the 10% reservation quota mentioned above, such vacancies will be filled up by the candidates included in the Ranked list prepared for open quota. In case the candidates included in the Ranked list could not secure appointment before the expiry of the Ranked list, the names of such candidates will be included at the top of the new Ranked list of the Low paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O(P) No.39/89/P& ARD dated 08.12.1989.

**NOTE (2)**:- According to the existing procedure, revaluation and rechecking of Answer Script is not allowed. Candidates who wish to obtain the scanned image and tabulation sheet of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in, by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five Only) via e-payment mode available in the portal. A period of 15 (fifteen) days time to apply for the image andtabulation sheet of answer sheets will be allowed to the candidates with effect from the date on which the recast Ranked List is uploaded in the website of the Commission (ie, on or before 12.12.2025). Application submitted in any other manner (ie, via Email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued.

**NOTE (3)**:- The candidate who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the commission to The District Officer, Kerala Public Service Commission, District Office, Thiruvananthapuram -695004. The format is available in the official Website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the prescribed format will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (4)**:- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list.
