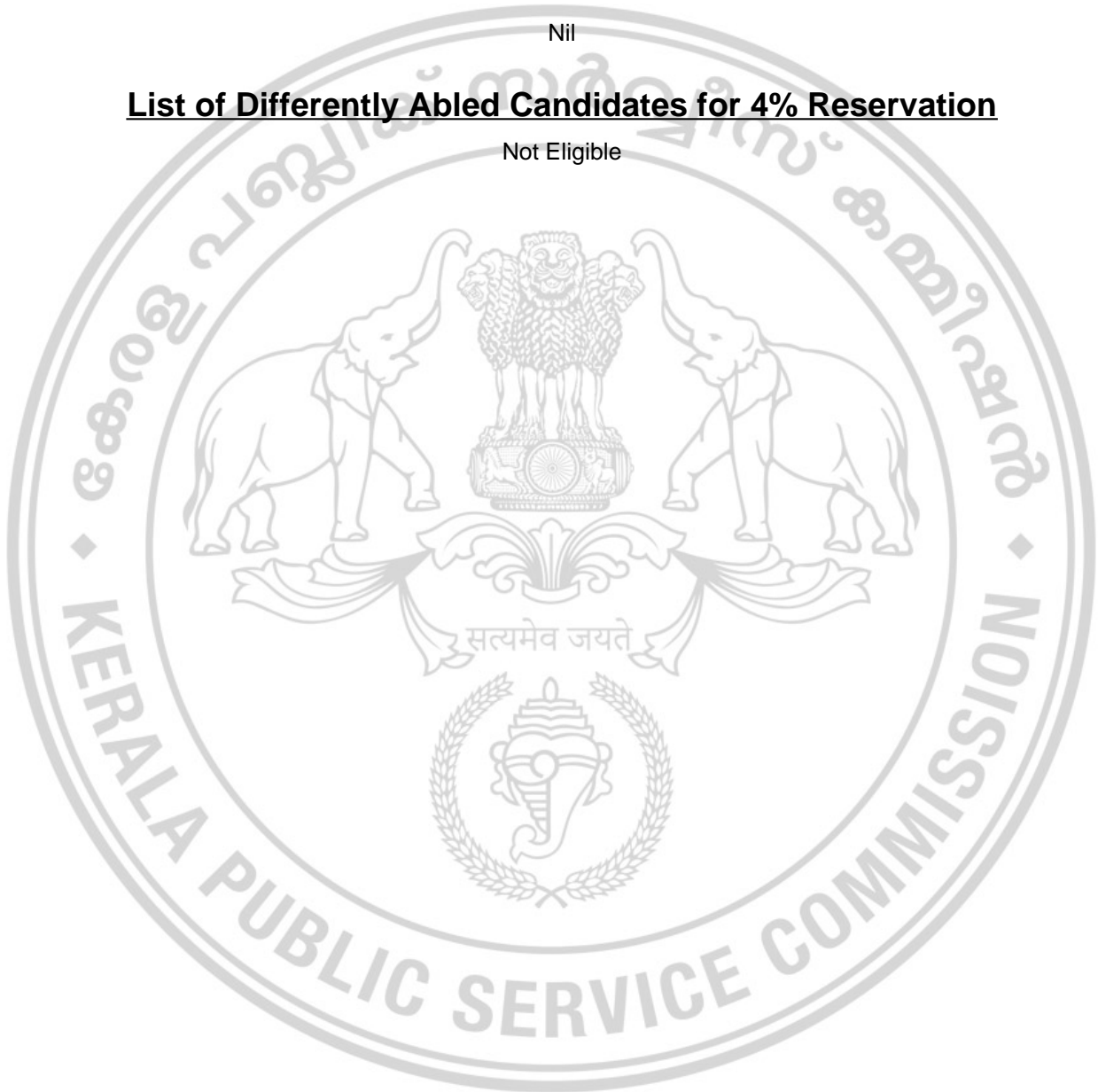

Date, Time and Venue of Verification and Practical Test will be informed through Profile Message / SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who are eligible for Reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate (For State Employment Purpose) obtained from Village Officer and SC/ST Candidates are required to produce Community Certificate (Form III /digitally signed) issued by the Revenue authority (not below the Rank of Tahsildar) and candidates who claimed EWS Reservation are required to produce EWS Certificate issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
