Note 4:- Candidates included in the Short List should present in person with Admission Ticket downloaded from the official website (www.keralapsc.gov.in) of the commission, Original ID, Medical Certificate as prescribed in the Gazette Notification (Fitness Certificate issued by an Assistant Surgeon & Certificate regarding eye sight issued by an ophthalmologist in Govt. service)and all other original documents for Practical Test (T Test & Road Test) & Verification. Date,time and Venue of Verification and Practical Test will be informed through Profile Message / SMS in due course .

Note 5:- Candidates included in the Short List belonging to Other Backward Classes eligible for reservation are required to produce Non -Creamy Layer Certificate as per G.O (MS) No.81/09/SCSTDD dated 26.09.2009 obtained from Village Officer and SC/ST Candidates are required to produce Community Certificate (Form III /digitally signed) issued by the Revenue authority not below the Rank of Tahsildar and candidates who claimed EWS Reservation are required to produce Income and Asset Certificate vide G.O (MS) No. 2/2020/P&ARD dtd 12/02/2020 issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents .

Note 6:- According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 26/08/2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscript is invalidated as per Notification No : ER7-2/14/2025-KPSC Dated 12/11/2025
