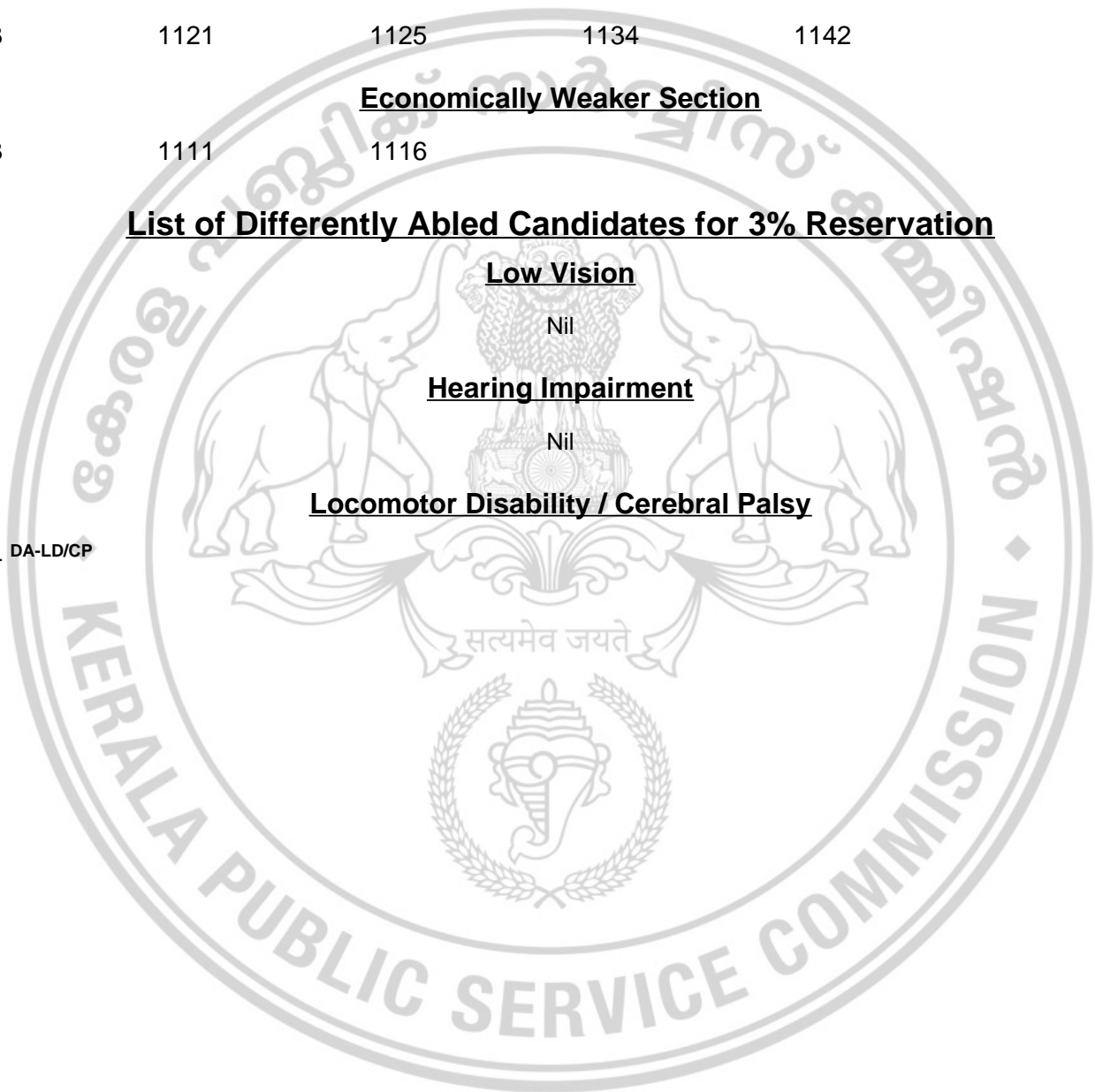

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the Dictation cum Transcription Test, based on the details furnished by the candidate in the application for the post. Subsequent claims made will not be entertained at any stage. The Register Number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (3) **12 (Twelve)** candidates who have secured topmost marks in the Dictation cum transcription Test held on 06.10.2025 are included in the Main List of the Short List. Marks secured by the last candidate of the Main List is **74.00 (Seventy Four (point) zero zero)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribe, Other Backward Classes, Economically Weaker Sections, Differently Abled, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated to candidates through Profile message and SMS in due course.**

Note :- (5) Candidates included in the Short List who belongs to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO(P) No. 81/09/SCSTDD dated 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahisildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(MS) no. 5/2020/P&EA dated 04.03.2020 along with other documents at the time of OTR Verification.

Note :- (6) Revaluation/Rechecking/ photocopy of answer scripts of Dictation cum Transcription test is not allowed.

Note :- (7) No answer scripts are invalidated as per Notification No : ER4-3/5/2024-KPSC dtd 22.12.2025
