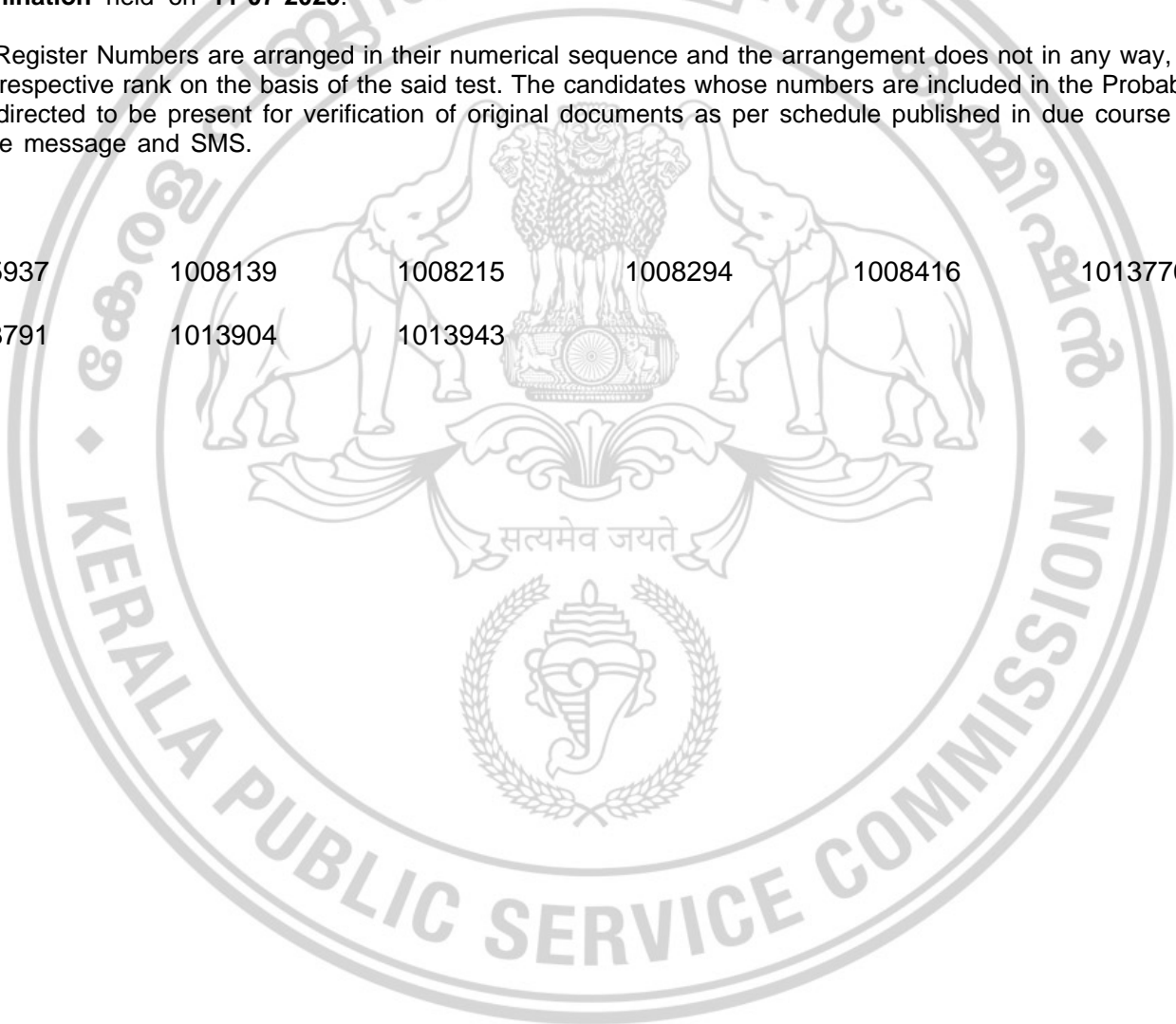

Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No. 3942/2018.R.D dtd 24.09.2018 and SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per G.O (Ms) NO.5/2020/P&EA dated 04/03/2020 along with other documents at the time of OTR Verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **11-07-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidate is invalidated for the above mentioned post vide Notification No : ER8-2/6/2025-KPSC dated 03/11/2025.
