Note :- (3) Date, Time and Venue of Physical Measurement , Physical Efficiency Test will be published in due course. At the next stage of selection process, a short list will be published for the Practical Test (Driving Test) by including the candidates who pass in Physical Measurement and Physical Efficiency Test.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated as per Notification No :ER7-2/14/2025-KPSC Dt 12/11/2025
