Note :- (3) Candidates included in the Short List should present in person and produce the original documents for Practical Test (T Test & Road Test) & One Time Verification. Date, time and Venue of Practical Test and One Time Verification will be informed through Profile Message / SMS in due course.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/ SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under Economically Weaker Section category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 03/2024/P&ARD Dated 25.04.2024 as proof of their claim, along with other relevant documents at the time of One Time Verification of original documents.

Note :- (6) Copy of answer scripts of the OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No :ER7-2/14/2025-kpsc dated:12.11.2025
