Note:- (2) The Short List has been prepared based on the details furnished by the candidates in the Application and subsequent claim, if any, will not be entertained at any stage.

Note :- (3) **70 (Seventy)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is **71.33 (Seventy One (Point) Three Three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section Category and other reserved categories if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Short List who qualify the Practical Test (H Test + Road Test) should be present in person and produce the original documents for One Time Registration Verification. **Date, Time and Venue of OTR Verification and Practical Test will be intimated through Profile Message and SMS.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009. SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.3/2024/P&ARD dated 25.04.2024 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the Common OMR Test held on 26.08.2025 will be issued to those candidates who apply for the same by remitting the prescribed fee after approval of the Ranked List. No answer scripts were invalidated for the post as per Notification No. **ER7-2/14/2025-KPSC dated 12-11-2025 of the Secretary, KPSC.**
