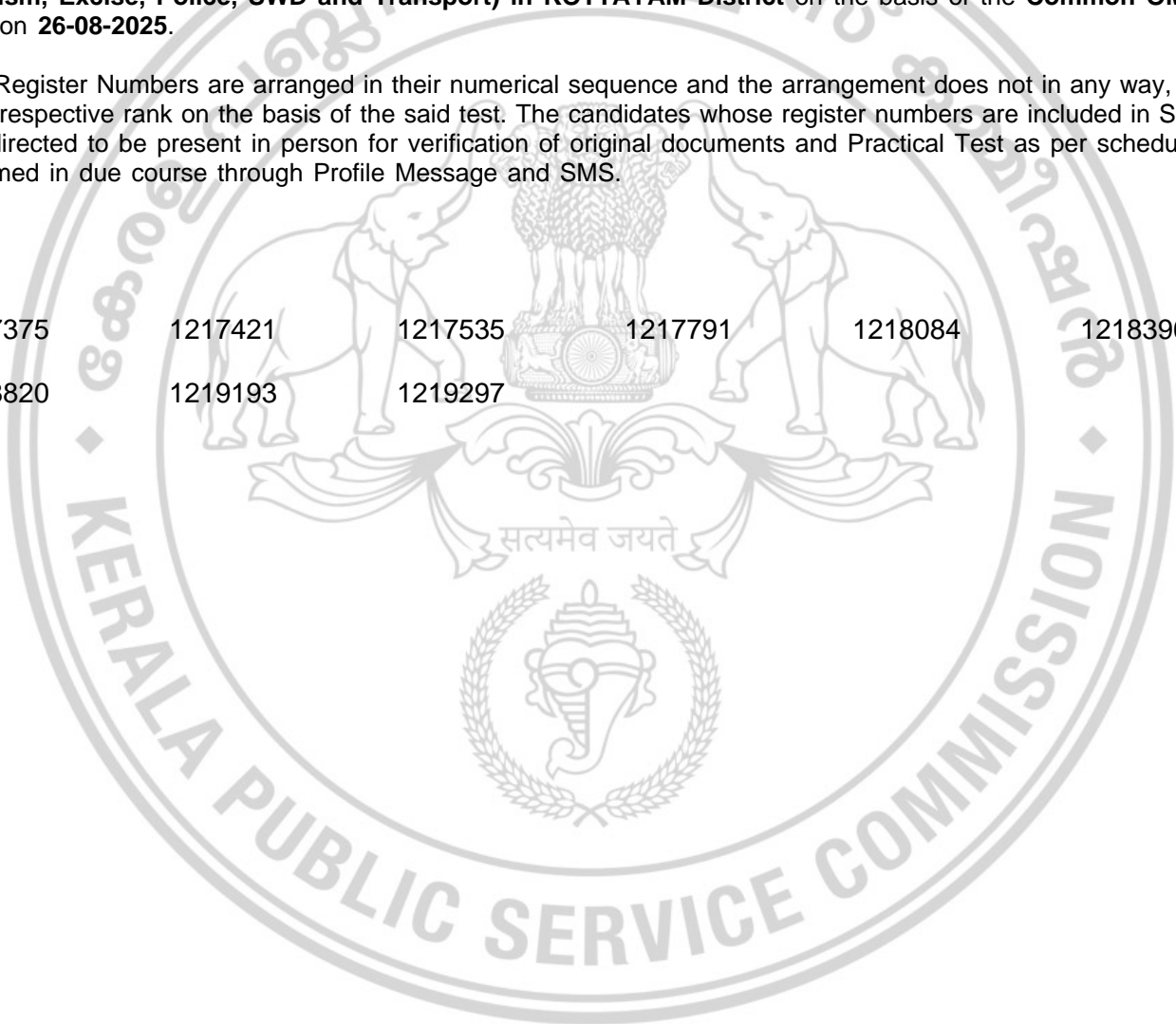

Note :- (6) Candidates included in the Short List are required to produce Service Certificate obtained from the Head of Office showing their service particulars in the prescribed form along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the Common OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts were invalidated as per Notification No :- **ER7-2/14/2025-KPSC dated 12-11-2025 of the Secretary, KPSC.**
