Candidates called for Practical Test will have to produce valid Driving Licence, Driving Licence Extract, a Medical Certificate regarding Physical Fitness, Medical Certificate regarding Vision and Service Certificate in the prescribed format available in the Gazette Notification.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.No answerscripts are invalidated as per Notification No:**ER7-2/14/2025-KPSC Dated 12/11/2025**
