Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the number of Eligible and Qualified candidates who have secured top marks in the OMR Test.

Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) **26 (Twenty six)** candidates who have secured topmost marks in the Common Main OMR Examination held on 26.08.2025 are included in the Main List of the Short List. The marks secured by the last candidate in the main list is **68.33 ( sixty eight (point) three three )**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :-(5) Candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of an Assistant Surgeon. A Medical Certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Driving Licence, latest DL extract etc. Form of Medical certificates is available in the Notification.

Note :- (6) Candidates included in the Short List who qualify in the Practical Test should present and produce in person the original documents for **One Time Verification. Date,time and Venue of Practical Test & OTR Verification will be intimated shortly.**

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate as per G.O.(MS) No.2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:- **ER7-2/14/2025-KPSC DATED 12/11/2025**
