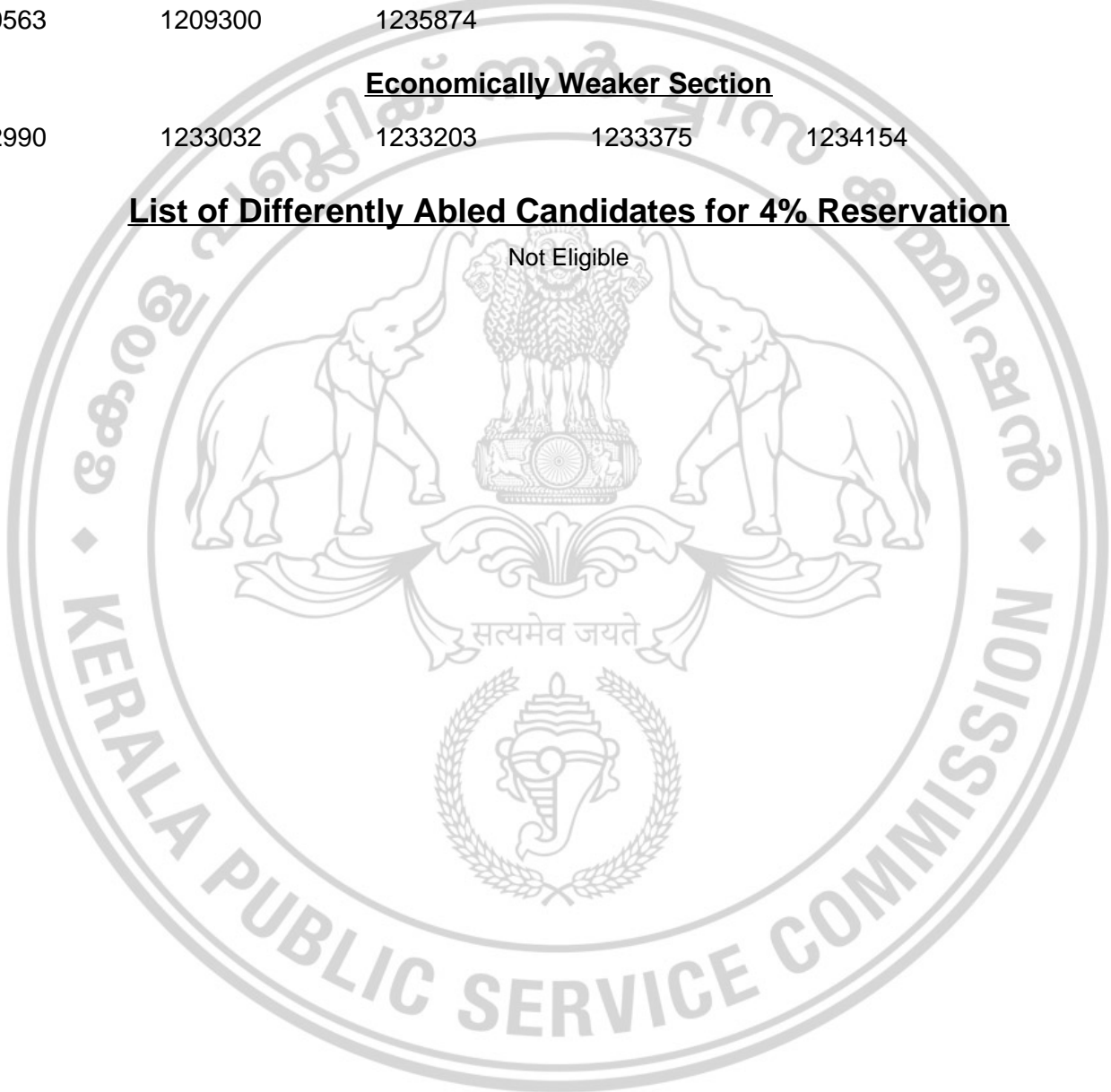

Note :- (3) 21(Twenty One) candidates who have secured top marks 73.33(Seventy Three Point Three Three) and above in the common OMR Examination held on 26/08/2025 are included in the Main List of the Short List. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

.Note :- (4) The Practical Test (T Test & Road Test)as specified in the Gazette Notification and One Time Verification will be conducted before the publication of the Ranked List. Date,Time and Venue of Practical Test and Certificate Verification will be intimated through profile message and SMS in due course. The candidates should download the Admission Tickets from the official website (www.keralapsc.gov.in) of KPSC and appear in person with their original ID Proof and other required documents for Practical Test.

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (MS) No. 02/2020/P&ARD Dtd.12.02.2020 as proof of their claim, along with other documents at the time of One Time Verification.

.Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the Common OMR Test held on 26/08/2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after publication of entire Ranked Lists which are to be finalized on the basis of the common test. No answer scripts are invalidated as per Notification No. ER7-2/14/2025-KPSC dated 12.11.2025.
