Candidates should download their Admission tickets for the above test and should appear in person with their original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Non-Creamy layer Certificate issued by the Revenue Authority and shall produce the same along with the other documents at the time of verification of original documents.

Note:- (8)Copy of answer scripts of the OMR Test held on 25-09-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
