Note :- (2) The Short List has been prepared based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) The list has been prepared by including all eligible and qualified candidates who have attended the OMR Examination.

Note :- (3) The candidates who have secured **70.33 (seventy (point) three three)** marks and above are included in the Main List of this Short List . For the purpose of satisfying the rules of reservation of appointments to Scheduled Caste, Scheduled Tribe and Other Backward Classes (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present for Practical Test (T Test + Road Test) and produce in person the original documents for One Time Verification. Date,Time and Venue of Practical Test and OT Verification will be published shortly. Candidates called for the practical test will have to produce Medical certificate in the prescribed form from a Medical Officer not below the rank of an Assistant Surgeon. A Medical Certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced along with other necessary documents such as valid Driving Licence, latest DL extract etc.Form of Medical certificates is available in the Notification.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate as per G.O.(MS) No.2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:- ER7-2/14/2025-KPSC dated 12/11/2025.
